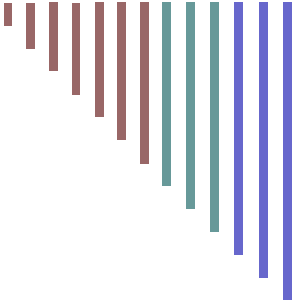
## Spring Craft & Gift Exhibition
